Bids will be received for the following Work:

This project includes the 3" milling and resurfacing of approximately 0.16 miles of Bellewood Drive, and 1.5" milling of approximately 0.20 miles of Bellewood Drive extending from Flushing Road to Oakwood Drive. The proposed improvements will include curb and gutter replacements, driveway replacements, drainage structure adjusts and new covers as needed. This project will also include other associated items like turf establishment and traffic control, potential sidewalk and sidewalk ramps as needed.
